Since 1988, the East Texas Food Bank has worked to feed our hungry neighbors in East Texas. Headquartered in Tyler, the East Texas Food Bank collects donated and purchased food and distributes the goods to more than 200 partner agencies. These agencies are located throughout the 26-county service area, which spans nearly 20,000 square miles, from Lufkin to Texarkana, and Athens to the Louisiana border. These food pantries, soup kitchens, emergency shelters, and other nonprofits then provide nourishing meals at no cost to the needy.

The East Texas Food Bank makes the absolute most out of their donors' generosity. For every dollar that is donated, up to eight meals are provided to those in need. The collected food is stored in their 75,900 square-foot facility and then much of the food is delivered directly to partner agencies and hunger relief programs.

Along with feeding children, the working poor, and seniors in East Texas, the East Texas Food Bank conducts classes teaching healthy eating and food budgeting, as well as helping individuals sign up for nutrition programs. The East Texas Food Bank works jointly with larger hunger relief organizations through their memberships with Feeding America and the Texas Food Bank Network. They are also one of four food banks serving the Gulf Coast region that are pre-staged with food products from Feeding America and FEMA to respond to disasters.

Throughout its history, many East Texans have passionately fought alongside the East Texas Food Bank in the fight for a hunger-free East Texas. These East Texans strive to help create a better tomorrow for those in their community and to provide a bright future for generations to come. Now, this vision can become a reality all through the power of legacy gifts.

ESTABLISHING A MEAL PLAN

Legacy gifts, also known as planned giving, can be made through a will or trust and use different types of assets. Just as a person is entitled to an immediate charitable tax deduction after making an outright gift to the East Texas Food Bank, there are numerous benefits to planned giving. If you include the East Texas Food Bank in your will, you may qualify for tax benefits. If you have a life insurance policy that you no longer need, you can transfer that policy as your legacy and receive a tax deduction. The East Texas Food Bank has established a full menu of planned giving opportunities to help you further your fight against hunger and extend your philanthropic efforts beyond your lifetime. There are many options for planned giving and you may choose the one that best fulfills your desired impact. Barbie, Adam, and their three children are an example of how life can take an unexpected turn and leave families in a bind. Their story sheds a light on how the East Texas Food Bank's pantries can help families get by and pave the way for others.

"We were basically living paycheck to paycheck like most families and we were just hit with a problem," said Adam. His wife, Barbie, broke her leg and the family suddenly had to rely only on his income as a high school history teacher. Without the double income, the family was forced to choose between paying the bills and buying groceries.

"We decided to put our faith in God and started using a food pantry. Every week it was just enough," said Adam. It was almost a year until Barbie could go back to work. Since then, they have decided to pay it forward by donating back. "The conversation came up of where we could give and who could we help. The food pantry kind of just hit us. We now know that's where God wanted us to put our money." It is a lesson of giving back that the family says they will not forget.

GIVING THANKS

The East Texas Food Bank conducts multiple anti-hunger programs, one of them being the BackPack Program. This program provides nutritious meals to low-income children who participate in school meal programs, but face hunger on the weekends. Shaunelius and her family are a great example of how these programs can make all the difference in the lives of those who participate.

"My children get a backpack from the East Texas Food Bank every Friday. That means I know my kids will have something to eat. That's a good thing because at the end of the month, it's tough," said Shaunelius. Her husband is currently unemployed due to a car accident and she is working a seasonal job that she hopes to turn permanent. "I'm just grateful to even have the opportunity to work, because for years I was sick all the time due to a cyst in my brain. A few years ago I had brain surgery to take care of it," said Shaunelius.


