THE HR COMMITTEE IS RESPONSIBLE FOR REVIEWING AND APPROVING THE CEO'S RECOMMENDED ANNUAL INCREASE RATE. THE CEO IS RESPONSIBLE FOR ADMINISTERING THE COMPENSATION PRACTICES AS APPROVED BY THE HR COMMITTEE AND THE BOARD OF DIRECTORS.

THE EXECUTIVE COMMITTEE OF THE BOARD OF DIRECTORS IS RESPONSIBLE FOR ADMINSTRATING THIS POLICY WHEN REVIEWING THE COMPENSATION AND BENEFITS OF THE CEO.
